STUDENT AGREEMENT AND SIGNATURE

By signing below, I confirm that the information I have provided is true and correct. I understand and agree to the following:

- **This is a waiver of tuition and course fees only. Course materials, textbooks, other fees, and any special costs are my responsibility.**
- Tuition waivers cannot be applied retroactively.
- If I do not achieve a grade of C or higher, or PASS, in the current course I will not be eligible for a waiver for the next course. In the absence of a waiver, I am responsible for the cost of attendance (personally or through scholarships or financial aid). However, after one successful course without using a tuition waiver, I can reapply for a waiver for the next course.
- **I must submit a tuition waiver for each course for which I would like tuition waived.**
- **One-Time Late Exception:** If you miss the waiver deadline, you may still be able to submit it with the President's approval, but this option is **only available once**. Subsequent late requests will not be accepted.
- If a student withdraws from a class, the tuition waiver will still be applied, but the withdrawal will affect future eligibility for the waiver.
- I authorize the Ilisagvik College Registrar's Office to release grades to the Finance Department.
- I give Ilisagvik College permission to use my name and image in marketing material.

TUITION WAIVER FAQs

Do I need to apply for a tuition waiver for each course?

Yes, an application is necessary for **each** course for which you would like to receive a tuition waiver.

Does this waiver apply to CEU classes?

CEU classes with course codes of HEO, SAFE, EMS, DE, and WFDx are eligible for this waiver.

I live off-Slope, am I eligible for this waiver?

No, you must have lived in the North Slope Borough for at least 30 days to be eligible for this waiver.

Does the student have to be admitted to a program, or can he/she apply for a waiver if he/she just wants to take an individual class?

This waiver is for individual courses and the student need not be admitted to a program.

When is the due date for the completed form to be turned in?

For short-term courses, the waiver is due before the end of the course.

Does a student have to have “A” grades in order to be eligible for a waiver?

No. However, when taking courses under this waiver, the student must achieve a grade of C or higher, or a PASS grade, in order to be eligible for a waiver for the next course.

Do students have to apply for a scholarship?

Not for this particular waiver, however, scholarship application is still recommended to cover any costs not covered by the waiver. For guidance on where to find scholarships, including scholarships with easy applications, contact the Financial Aid Office.

Does the waiver include the cost of books?

No. The tuition and course fees will be waived, but students are responsible for course materials, textbooks, other fees, and any special costs identified for the course(s).

Does this waiver apply to dual credit courses?

No, it does not.

What if I withdraw from a course?

If you withdraw from a course, it is the policy of Iñisagvik to apply the waiver to the tuition. However, the withdrawal may affect your eligibility for the waiver in future courses. When possible, it is better to drop a class before the drop deadline, rather than waiting until the withdrawal deadline.

Can the tuition waiver be applied to repeat classes, either because the student did poorly or because the student wants to take the class again for personal interest?

No, the tuition waiver can be applied once to a class, but not repeatedly.

Does this waiver apply to audited classes?

No, classes that are being taken as “audit” do not qualify for a tuition waiver. The class must be taken for academic credit to be eligible.
